

ORDINANCE NO. 2019 - 72

AN ORDINANCE AUTHORIZING THE CITY OF KENT TO SUBMIT THREE (3) FUNDING APPLICATIONS TOTALING \$920,000 AND TO EXECUTE THE SUBSEQUENT AGREEMENTS WITH THE OHIO PUBLIC WORKS COMMISSION (OPWC), AND TO ACCEPT THE GRANT, IF AWARDED, WITH CORRESPONDING APPROPRIATION OF FUNDS AND DECLARING AN EMERGENCY.

WHEREAS, the first application submitted to OPWC will be for the Walnut Street Reconstruction-Phase 1. This project includes the installation of asphalt pavement, curbs, storm sewers, water mains and sidewalks on Walnut Street from Cherry Street to Harris Street. We are requesting \$250,000 in grant funds and \$50,000 in no interest loans from OPWC; and

WHEREAS, the second application submitted to OPWC will be for the Harris Street Rehabilitation Project. This project consists of rehabilitating Harris Street from Franklin Avenue to West Street with complete pavement replacement and replacement of curbs, sidewalks and drive aprons. We are requesting \$320,000 in grant funds and \$50,000 in no interest loans from OPWC; and

WHEREAS, the third application submitted to OPWC will be for the Water Tank Painting and Rehabilitation. This project consists of painting and rehabilitating of one of the low service water tanks located on Kent State University property. We are requesting \$250,000 in grant funds from OPWC.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, at least three-fourths (3/4) of all members elected thereto concurring:

SECTION 1. That Kent City Council approves submission of the City's capital project pre-application requests for Ohio Public Works Commission grant and loan funding totaling \$920,000 and authorized that the Administration provide all information, funds, and documentation required in said applications for submission.

SECTION 2. That the Kent City Council hereby approves the City's acceptance of the grant(s), if awarded to the City, with corresponding appropriations for its use.

SECTION 3. That the Kent City Council hereby understands and agrees that participation in the OPWC grant program will require compliance with program guidelines and assurances.

SECTION 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 5. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
