

ORDINANCE NO. 2009 40

**AN ORDINANCE AUTHORIZING AN ADDITIONAL EXTENSION OF ORDINANCE NO. 2006-61, PASSED MAY 17, 2006, AND AMENDMENTS THEREOF, OF THE GENERAL COMPENSATION PLAN FOR ALL UNCLASSIFIED AND VARIOUS CLASSIFIED EMPLOYEES OF THE CITY OF KENT, EXCEPT THE CITY MANAGER, TO JUNE 28, 2009, OR, AND AT THE DISCRETION OF THE CITY MANAGER, AN ADDITIONAL SIXTY (60) DAYS, FROM JUNE 28, 2009, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the General Compensation Plan for all unclassified and various classified employees of the City, expired On December 31, 2008; and

**WHEREAS**, the City of Kent previously extended the plan until February 28, 2009, or, at the discretion of the City Manager, an additional sixty (60) days, from February 28, 2009; and

**WHEREAS**, an additional extension is needed.

**NOW, THEREFORE BE IT ORDAINED**, by the Council of the City of Kent, Portage County, Ohio, at least three-fourths (3/4) of all members elected thereto concurring:

**SECTION 1.** That Ordinance No. 2006-61, passed May 17, 2006, and amendments thereof, be and hereby are amended to extend the effective date of said compensation plan to June 28, 2009, or, at the discretion of the City Manager, an additional sixty (60) days, from June 28, 2009, and declaring an emergency.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare o the residents of this City, for which reason and other reasons manifest to this Council this ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
