

ORDINANCE NO. 2016-94

AN ORDINANCE AMENDING SECTION 353.02 OF THE CODIFIED ORDINANCES OF THE CITY OF KENT ENTITLED "PARKING REGULATION AUTHORIZATION".

WHEREAS, the City of Kent's Traffic, Engineering, and Safety Committee reviewed the current on-street parking restrictions on Morris Road, and has made a recommendation to change the parking restrictions to improve traffic movement and safety; and

WHEREAS, the Kent City Council wishes to adopt said recommendation, and modify Section 353.02 of the Codified Ordinances so as to incorporate that recommendation; and

WHEREAS, seventy percent (70%) of the residents in that area were advised of said changes and signed a petition agreeing to the changes; and

WHEREAS, time is of the essence as this change will improve the traffic movement and safety.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, at least a majority (5) of all members elected thereto concurring:

SECTION 1. That Council does hereby amend Section 353.02 of the Codified Ordinances of the City of Kent entitled "Parking Regulation Authorization" in order to authorize the following amendment:

MORRIS ROAD - NO PARKING BOTH SIDES EXCEPT THE EAST SIDE FROM BERYL DR. SOUTH TO THE DEAD END WITH NO RESTRICTIONS

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council, this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
